It is with great pride and gratitude, the council acknowledges all the stakeholders for their unflinching commitment and support rendered in all the initiatives of AICTE particularly in the Approval Process 2021-22. It is worth highlighting that the council is working meticulously on various measures for the quality improvement in Higher Educational Institutes, notably in Institutions offering Technical Education. It is also worthy to record that the Approval Process of 2021-22 had some major and effective changes as advocated in the National Education Policy (NEP) 2020.
